## Chung Yuan Christian University Guidelines for the Prevention and Control of Measles and Varicella

Approved by Meeting of Health Services and Dietary Committee at 2<sup>nd</sup> semester of 2025 on June 23, 2025

- Article 1. To prevent the occurrence and spread of measles and varicella on campus, Chung Yuan Christian University has established the "Chung Yuan Christian University Guidelines for the Prevention and Control of Measles and Varicella" in accordance with "The Communicable Disease Control Act" and "The School Health Act".
- Article 2. In the event that any suspected or confirmed case of measles or varicella is identified on campus, it shall be proactively reported to the Health Services Division. It shall actively follow up on the case, report it to the competent health authority in accordance with relevant regulations, and cooperate in implementing subsequent prevention and emergency response measures to prevent the spread of the disease.
- Article 3. Individuals diagnosed with measles or varicella shall cooperate with medical examination and treatment, and shall implement appropriate protective and isolation measures as required:
  - 1.Measles cases shall be isolated from the onset of rash through at least the fourth day thereafter.
  - 2. Varicella cases shall remain in isolation until all vesicles have crusted over and dried. Return to campus is permitted only after the isolation period has ended and there is no further risk of transmission.
- Article 4. In the event that a measles case or a varicella cluster is confirmed by the competent health authority, actions shall be taken in accordance with the relevant regulations of the central and local authorities and "the CYCU Regulations Governing Prevention of Infectious Diseases on Campus". If necessary, the Emergency Response Team shall be activated, and cooperation with health authorities shall be carried out to implement follow-up epidemic control measures.
- Article 5. For areas on campus where confirmed measles cases or varicella cluster cases have stayed or been active, the Center for Environmental Protection and Occupational Safety and Health shall be notified to arrange for disinfection procedures.
- Article 6. The collection, processing, and use of case-related information shall comply with the provisions of the Personal Data Protection Act. All information shall be kept confidential and shall not be disclosed without proper justification. However, disclosure is permitted when necessary for educational, counseling, or medical purposes. All records shall be maintained by the Health Services Division, with appropriate and secure data protection measures in place, and retained for a period of ten years.
- Article 7. During periods of disease outbreaks, the Health Services Division shall actively promote diversified epidemic prevention education to enhance the accurate understanding of measles and varicella prevention and control among faculty, staff,

and students. Recommended measures include wearing masks, practicing proper hand hygiene, and following cough etiquette to effectively reduce the risk of virus transmission. In response to government policies, the Health Services Division shall also assist in promoting vaccination to strengthen individual protection awareness and improve overall epidemic prevention effectiveness.

Article 8. These guidelines, having been approved by the Health Services and Dietary Committee, are submitted to the president for approval and promulgation, with the same process followed for any future amendments.
