Chung Yuan Christian University Guidelines for the Prevention and Control of Dengue Fever and Chikungunya

Approved by Meeting of Health Services and Dietary Committee at 2nd semester of 2025 on June 23, 2025

- Article 1. In order to prevent the occurrence and spread of dengue fever and chikungunya on campus, Chung Yuan Christian University has established these Guidelines for the Prevention and Control of Dengue Fever and Chikungunya, in accordance with The Communicable Disease Control Act and The School Health Act.
- Article 2. These guidelines apply to all faculty, staff, and students of the University, as well as all teaching, administrative, public, and dormitory areas on campus.
- Article 3. Dengue fever and chikungunya are classified as Category II notifiable communicable diseases. If any suspected or confirmed case is identified on campus, the Health Services Division shall carry out case reporting and prevention measures in accordance with relevant regulations.
- Article 4. Once a confirmed case of dengue fever or chikungunya on campus has been verified by the competent health authority, the University shall act in accordance with the relevant regulations set forth by central and local authorities, as well as the "CYCU Regulations Governing Prevention of Infectious Diseases on Campus." If necessary, an emergency response task force shall be activated, and follow-up epidemic prevention measures shall be carried out in coordination with the competent health authority.
- Article 5. Each unit shall implement proper campus environmental management, including regularly inspecting and removing potential mosquito breeding sites, such as plant pot trays, rainwater drain grooves, water storage containers, drainage ditches, and various discarded containers. If any breeding source or high-risk area is identified, the unit shall report it to the Center for Environmental Protection and Occupational Safety and Health for disinfection. In addition, all units shall cooperate with the competent health and environmental authorities in vector control, disinfection, and spraying operations to reduce the risk of disease transmission.
- Article 6. Upon receiving a report of a suspected or confirmed case, the Health Services Division shall initiate active follow-up. During the infectious period, the individual shall cooperate with tracking and health monitoring to ensure continuous health support and return to school life.
- Article 7. The collection, processing, and use of case-related information shall comply with the provisions of the Personal Data Protection Act. All information shall be kept confidential and shall not be disclosed without proper justification. However, disclosure is permitted when necessary for educational, counseling, or medical purposes. All records shall be maintained by the Health Services Division, with appropriate and secure data protection measures in place, and retained for a period of ten years.

- Article 8. The Health Services Division shall strengthen health education efforts in accordance with epidemiological trends prior to epidemic seasons, promoting disease prevention concepts through diverse channels to enhance individual self-protection awareness.
- Article 9. These guidelines, having been approved by the Health Services and Dietary Committee, are submitted to the president for approval and promulgation, with the same process followed for any future amendments.
