- Article 1. CYCU hereby establishes the Regulations in order to conduct the students' conduct points evaluation objectively, correctly, strictly and fairly.
- Article 2. The basic conduct points desirable by any student who has never been disciplined by the end of any semester may be increased from 82 points to 85 points automatically, with the rewards to be granted separately, while the student who has been disciplined by the end of the semester may receive the basic points, 82 points, only. The actual total points come out after addition or deduction of the points given by the advisor or department military instructor and reward & disciplinary points; 95 points refers to the full mark.
- The students' conduct points are categorized into the 5 grades.
1. 90~95 points: Excellent
 2. More than 80 points but less than 90 points: Grade A
 3. More than 70 points but less than 80 points: Grade B
 4. More than 60 points but less than 70 points: Grade C
 5. Less than 60 points: Grade D, namely failure.
 6. The evaluation points more than 95 points shall be counted as 95 points, and some honorary reward shall be given with respect to the excess of points.
- Article 3. The students' conduct points shall be evaluated by the advisor and department military instructor jointly.
1. The students' conduct points shall be evaluated, separately, by the advisor, who is entitled to add or deduct 5 points, and the department military instructor, who is entitled to add or deduct 3 points.
 2. In the case of the student disciplined with reward or punishment, the points shall be added or deducted in the following manners:
 - (1) One commendation for additional 1 point; one minor merit for additional 2.5 points; 1 major merit for additional 7.5 points.
 - (2) One reprimand - minus 1 point; 1 minor demerit - minus 2.5 points; 1 major demerit - minus 7.5 points.
 3. The department chair and faculty may enumerate the facts about the students' conduct points and provide the same in writing as the reference for the evaluation.
- Article 4.
1. The students' conduct points refer to the total of the basic points, advisor's points, department military instructor's points and reward & punishment points.
 2. Where the points are added or deducted by 3 points or more, please enumerate the relevant facts.
- Article 5. Upon completion of the students' conduct points evaluation, the Office of Academic Affairs shall notify the evaluation result, together with the students' academic

performance, to their parents or guardians.

Article 6. The students' total conduct points refer to the actual points generated based on the average of their conduct points for each semester.

Article 7. The Regulations are passed by CYCU's Student Rewards and Disciplinary Committee, and shall be promulgated and enforced by the President. The same shall apply where the Regulations are amended.
