## CYCU Regulations Governing Conferral of Holistic Benchmarking Awards

- Article 1. CYCU offers the holistic benchmarking awards to establish the peer learning benchmark to lead students to develop comprehensively and train excellent talents to serve the society and achieve the holistic educational target.
- Article 2. The holistic benchmarking awards include the following:
  - 1. Holistic honorary award: Applicable to CYCU's undergraduates no more than 50 persons per year.
  - 2. Holistic benchmarking award: Applicable to CYCU's fresh graduates no more than 10 persons per year.
- Article 3. The actual quota of the holistic benchmarking awards shall be authorized subject to the amount of budget for the current school year.
- Article 4. Any student who satisfies any of the following conditions may apply for the holistic honorary award:
  - 1. With the GPR for the previous school year ranking top 10% of the class or department and also satisfying any of the following conditions:
    - (1) Participating in any association (evaluated to be excellent) and holding an important position, as proven by specific evidence.
    - (2) Participating in important competitions and winning awards therefrom (including group competitions).
    - (3) Satisfying CYCU's holistic education activity certification Grade-B (standards applicable through the school year) or above.
  - 2. Winning important national awards, publishing papers in domestic/foreign academic journals with peer-review system or making special contribution by significant good work and achieving the GPR ranking among the top 30% of the class or department in the previous school year.
  - 3. Winning important international awards, publishing papers in international academic journals or engaging in major voluntary deeds and achieving the GPR ranking 50% of the class or department in the previous school year.

Any students who apply for the holistic honorary award shall have the physical education performance attain 70 points or above and be free from any demerit or more (including accumulated punishment).

- Article 5. The holistic honorary award consists of the following:
  - 1. One certificate of merit
  - 2. Scholarship in the amount of NT\$10,000
- Article 6. Deferred students, students who leave CYCU because of transfer to another school, drop out or graduation shall not apply for the holistic honorary award.
- Article 7. Any student who satisfies any of the following conditions may apply for the holistic benchmarking award:
  - 1. Satisfying any of the following conditions in terms of GPR:
    - (1) With the historical average GPR ranking at top 10% of the class;
    - (2) Engaging in significant good work, making special contribution or winning

- important national awards, and achieving the historical average GPR ranking top 30% of the class;
- (3) Winning important international awards, publishing papers in international academic journals or engaging in major voluntary deeds and achieving the historical average GPR ranking 50% of the class.
- 2. Receiving no more than one demerit and achieving the historical average physical education performance more than 70 points before graduation.
- 3. Satisfying CYCU's holistic education activity Grade-A (standards applicable to graduates).
- 4. Participating in at least one of the school-wide workshops for leadership, parliamentary procedures, characters and creativity.
- 5. Taking the minor specialty program (including minor subject, double major and any interdisciplinary program) offered by CYCU for more than 10 credits as recognized by the Office of Academic Affairs.
- Article 8. The holistic benchmarking award consists of the following:
  - 1. Logged in CYCU's milestones and displayed in the history museum.
  - 2. Recommended by the President to continue education or seek employment as a special case.
  - 3. Awarded the career development seed fund categorized into outstanding, excellence and Grade-A. NT\$200,000 for the outstanding award, NT\$100,000 for the excellence award, and NT\$50,000 for the Grade-A award.
  - 4. Exempted from the tuition and miscellaneous fees in full for continuing education at the master program of CYCU; awarded NT\$100,000 for continuing education at the doctoral program of CYCU.
- Article 9. The holistic honorary award and holistic benchmarking award shall be conferred in the following manners:
  - 1. The students who apply for the holistic honorary award shall, by the end of October of each year, and the students who apply for the holistic benchmarking award shall, by the middle of March of each year, submit the relevant certificates to the Office of Student Affairs.
  - 2. Upon acceptance of the application by the Office of Student Affairs, the candidates will be submitted to the relevant department for nomination upon the primary review completed by the related unit (subject to the public announcement for thirty (30) days, in the case of the holistic benchmarking award).
  - 3. The candidates will be reported to the President for authorization upon reexamination by the holistic honorary award review committee, and then awarded and commended in public.
- Article 10. The holistic benchmarking award review committee shall consist of 9~15 members, including the Vice President as the convener, and Dean of Student Affairs and Dean of Academic Affairs as the ex officio members, as well as the other members to be selected by the President.
- Article 11. The Regulations shall be promulgated by the President and enforced upon approval of School Administration Council. The same shall apply where the Regulations are amended.
